#### APPLICATION INFORMATION

Dispensing	Sikament® R-4 can be added directly to the gauging water prior to its addition to the dry mixed aggregates or simultaneously with the gauging water at the batching plant.  When added directly to the freshly mixed concrete, the plasticizing effect is more pronounced.  For addition at job site, Sikament R4 is added to the concrete immediately prior to discharge and after further mixing has taken place for three minutes.
