Soak a clean rag or lint-free paper towel in Sika® Colma Cleaner and clean the bonding areas to remove surface contamination. Tightly reseal the container immediately after each use.

After a flash-off time of 15 minutes apply the appropriate Primer or Aktivator and respect relevant flash-off times again.
